Application/Limitation

This system is only to be used as engine control and monitoring system for auxiliary and propulsion marine engines.

1. An independent safety system shall be installed in addition to this control system.
2. Safety actions performed by control system shall be adjusted in line with independent safety system.
3. Safety actions that are in addition to the ones required by DNV GL Rules, shall have possibilities to be overridden or eliminated, "AUTO RESET" function shall be disabled.

Approval conditions

The following documentation of the actual application is to be submitted (preferably by the maker integrating overall engine automation) for approval in each case:

- Reference to this Type Approval Certificate
- System block diagram
- Power supply arrangement (may be part of the system block diagram)
- List of controlled and monitored points showing alarms and safety functions (including type, range and threshold)
- Test program for certification

The Type Approval covers hardware and software listed under Product description.
The current software numbers and versions are listed in software installed on the unit. To enter SW revision press Config and go to Setup>About (SW Revision).

Revisions for each software are listed in document "M2500 firmware release history".

The document M2500 Firmware Release History is used for software version control. Major changes should affect first digit. Minor software changes causing change in second or third digit of the software version will require update software changes log (M2500 Firmware Release History) in the type approval certificate in every second year (software changes log shall be submitted together retention survey report). Reference is made to clause for application software control for follow up.

Product certificate

Each delivery of the application system **is to be certified** according to Pt.4 Ch.9 Sec.1. The certification test is to be performed at the manufacturer of the application system, preferably at the engine/system application maker integrating control, monitoring and safety system, before the system is shipped to the yard.

Clause for application software control

When the type approved software is revised (affecting all future deliveries) DNV GL is to be informed by forwarding updated software version documentation. If the changes are judged to affect functionality for which rule requirements apply a new functional type test may be required and the certificate may have to be renewed to identify the new software version.
